- I attended the Fall Assembly September 10th in Elburn. Our Treasurers breakout session
 was combined with Secretaries and Registrars. It was brought up for Area officers and
 committee chairs allowed to expense mileage to their budget. Currently, IRS allows \$0.625
 for business miles and \$0.14 for charitable miles. The area allows \$0.40. It was said they
 wanted to be somewhere in the middle. I could not find an allowance in our District 11
 service manual.

Lisa: Do we not do that?

Keith: we do not have a set line item that can expense mileage to perform work on behalf of AA. maybe 14 cents or 18 cents per mile.

The cost of performing duties on behalf of the district, this should help.
