- I will begin by sharing a little information gathered from GSOs quarterly report.
- The literature committee has reviewed a progress report on the 4th edition translation to plain and simple language. The committee initiated a conversation on respecting AAs spiritual foundation by keeping the 12 steps intact and in place in chapter 5 and placing a possible differently formatted/design plain language translation afterwards. Also a new jacket-less format for the Big Book has been implemented for the next printing. This format will help to avoid supply chain issues and save in off press delivery time as well as expense. The first printing was expected to begin in October.
- An update on where we are at as far as the newcomer packets. I brought the requested amount from last month's meeting with me tonight as well as additional packets to bring back to the groups. Which will leave us with just under 75 in our possession. I will be placing an order soon so we have a sufficient amount on hand ready to distribute to men and women new to AA. Also, last month I committed to putting together a recommendation for a new less overwhelming yet still informative packet. After doing some research online checking out digital newcomer packets and reaching out to neighboring districts -special thanks to district 22 for responding and sharing what their packet contains. My recommendation for our newcomer packets will include: Information on AA (which is a single sheet flier) A Newcomer Asks, This is AA, Questions and Answers on Sponsorship and a 12 & 12/serenity prayer wallet card. The committee is open to any comments, concerns, questions or suggestions on the newcomer packet before placing the next order.
- I am also looking into putting together a literature display for the district to have for our monthly
  district meetings and possibly to put out at the upcoming assembly, which will include information
