- I had a portion of our District 11 Archives Display set up at Soberfest the whole weekend. I was in the room at times during the weekend. It appears we share those duties with Soberfest and Al Anon. The room is closed during speakers and at night. I will ask for some volunteers next year. One of our binders has pictures of old and new District 11 meeting places. If your group wants to send current 8 ½" x 11" pictures of your meeting places, I will add them to this binder.
- There are also a couple pictures of older and/or deceased members in there. I'm not really sure how I feel about that, but I am going to leave as is.
- I donated many Grapevines to our Archives, to fill in some gaps and to start bringing the collection current.
- I donated 2 3" 3 ring binders I had that I don't see a use for, to replace damaged 3 ring binders.
- I purchased:
  - 1 1" 3 ring binder to replace a damaged one
  - 1 package of 50 sheet protectors (that I have already used most of)
  - 4 20 Gallon totes that are better suited in size and shape to hold 3 ring binders.

- That is a total of \$67.29 of my \$100.00 2022 budget. I will give those receipts to our Treasurer tonight.

## Literature: Jake - Chair, OPEN - Alt. Chair

- I want a \$600 budget.
- The first order of business, is the literature committee recommends that the 2023 budget remains as it was in 2022 at \$500.
- I recently made a purchase totaling \$388.01 from AAWS. The receipt is included with my report. We now have enough inventory on hand to make 300 newcomer packets. I brought 30 with me tonight and they are on the back table ready for distribution.
- Included with the order we did get 15 assorted general service pamphlets (25 40 of each) and 6 service manuals.
- The service manuals are for sale for \$4, let me know if you are interested in purchasing a copy.
- The initial order included 16 assorted pamphlets plus a literature display rack for the
  district, however these items are on backorder. They are due back in stock shortly, as of
  last Saturday this was not the case. There are some pamphlets on the back table for
  anyone interested.
- And finally, last month I reported that AAWS was releasing a jacket-less format of the Big Book to avoid supply chain disruptions. I did not mention that the 12 & 12 will also be undergoing the same update. The books will look exactly as they do now with the image from the dust jacket printed directly on the book cover.
- AAWS released a formal announcement on October 15th to notify the fellowship and I have included the letter with this report. I mention this because as the books start to come into circulation, as informed members of AA, we will be able to explain based on facts directly from AAWS what has brought on this change. With hopes of generating some curiosity and excitement throughout the fellowship concerning our literature and ultimately getting the groups and its individual members more involved.

# LCM Report: Sue C.

What is an outside issue?

The GSC Final Report is now public record. Any Corporation could say, that hey, looks, even AA is on board with this change.

Lisa: So we want to switch back to "men and woman"

Rick: But the record is to rescind it.

Sue: This is the method of which things are brought to the GSC.

Keith: Chris is our Delegate. He went to everything. Was this figured out? What was the outcome?

In the final report of the 72nd conference. What was the outcome?

Sid/Rick: It was Take No Action.

Chris: They said they didn't have enough time yet to determine the impact on the fellowship.

Joe: It was decided to take no action, why do we have a motion to rescind it?

Sid: 71st conference made the change. 72nd talked about concern about the impact of the change, but too soon. So Rick is stating their opinion to bring it up the service structure.

It would ultimately be presented to our delegate, and put into the agenda for the 74th conference. Or if it can be brought up by the area and brought to the 73rd conference.

Sue: grapevine owns the preamble.

Carol: this could become a floor action at the 73rd conference.

Clint: I think there's some history to support this . The Washingtonians, very focused on 1 alcoholic relating to another one. But they got involved in outside issues. This was 50 years before AA. and the group went down real fast.

Steve: The change could establish a precedent for further changes.

Mark: At what point are we talking gender neutrality and inclusivity, being considered a controversial issue?

Rick: I look at general society. There's just very strong opinions on both sides. It's not a settled science. There are different definitions of gender. If AA took a stance on Nazi germany, and said it was bad. That would be incorrect. They didn't take a stance, they stayed out of it.

Sid: What was your group's vote?

Rick: 15 in favor, 2 opposed. Minority opinion spoke. And I understand their point.

Rick: Basically, did we break tradition 10?

Richie: John the senior editor, what did he say?

Rick: He was shocked. Your details are correct. But he didn't understand it being a controversial issue.

Sid: gives a service structure run down. Collective conscience of our whole fellowship.

• Literature (Jake) budget increase.

Richie: He's done good work. Doesn't need to increase the budget.

Motion: Vote: 19, 0 opposed.
