DCM Report: DCM: Dan P. / Alt. DCM: OPEN

Good evening District 11,

I hope everyone has been enjoying the beautiful weather.

On September 7th I attended the Fall Assembly.

- Area Finance: PPR 25.2% remaining budget PPM: 44.2% remaining budget.
- **GSB Finance**: Contributions up, literature sales down, but margin up than. Operating costs down. Prudent Reserve: 6.2 Months Operating Expense.
- Founder's Literature Motion: Substantial unanimity needed: Failed 64%/36% (56:32). I voted in opposition of this motion.
- Archives Chairperson Motion: Substantial unanimity needed: Failed 45%/55% (38:46). I voted in favor of this motion.
- Accessibilities Motion: Simple majority needed: Passed 88%/12% (72:10). I voted in favor of this motion.
- **ERC Trustee Nomination**: Rich H. elected as candidate after 5 rounds of Third Legacy procedure and being selected from the hat.
- Trustee at Large (US): Robert S. stood unopposed and was elected as candidate in one vote.
- Physical copies of the 2024 Conference report are available. There is a box on the table in the back. If we need more, I will contact Erik and get them to any group who wants one.

On September 12th I hosted the Legacy of Service: AA Service Manual and Concepts Study. I waited 15 minutes, and no one joined, I've heard interest from a few parties and will be texting them the week of October 10th in an attempt to boost attendance. If you or anyone in your group is interested in learning about our service structure and concepts, I would recommend they oin us the second Thursday of each month.

On September 28th we hosted D10/11/12 & NIA20 CPC/PI Workshop at Shepherd of the Prairie. Thank you to all who were able to make it out. The event was well-attended with about 40 members. I have questions out to the webmaster to potentially save 2 months of website fees. This is currently being looked into. I am hoping for a decision before our next meeting.

All expense reports received have been processed and checks issued.

All donations have been deposited.

Our Alt. Treasurer Bud is out with a broken ankle. When he is mobile, he will be taking care of sending the receipts to the donating groups.

Because every check that is written has to be accounted for on the expense budget, I added a line to the 2024 budget for the Old Timer's Brunch. This reflects a negative \$200 for the hall rental. This OTB line will be added to the future budgets so the transactions can be properly documented. I recommend for the 2025 budget OTB is earmarked \$1,700 based on \$1,500 seed and \$200 hall rent. If not, their budget will show a \$1,700 deficit at the end of 2025. Money received from the event will continue to be tracked on the income report.

Over the past month we have had Income of \$774.00 and Expenses of \$2,684.22. This puts our available funds at \$7,186.04 based on current prudent reserves.

- First, there may be a new opportunity to serve at MCC. Some conversations have begun discussing the possibility of bringing Alcoholics Anonymous into the facility. This is a result of some nursing students and faculty attending the AA meeting held at Northwestern Behavioral. We are excited about this and we're waiting for further developments.
- Secondly, we discussed creating a bridge the gap contact list for the treatment settings. We are hopeful this list of local willing members given to residents and patients will aid in a relatively smooth and more importantly successful transition from treatment to AA.

We are also looking to gather information regarding a monthly commitment that was also held at Northwestern by a member who recently has passed on. A staff member did inform us they currently do have a contact however no additional information was given. The committee is asking if anyone has any additional information on the commitment Kevin had at Northwestern to please let Natae or myself know. We would like to keep a record of who has this covered and offer any assistance if needed.

At Rosecrance we were able to send two members for an intro to AA presentation to the IOP patients. This is a quarterly commitment and we will be looking to visit again in December. There is also a beginners step meeting held the second Tuesday of each month at 6pm. Attendance has been good there but we're always welcoming to any AA members willing to carry the message.

Gateway in Lake Villa is looking for women to go and participate in their Friday night meeting. There is a contact available for anyone interested in attending.

Northwestern Behavioral in Woodstock has opportunities to serve as well. The current openings are Thursdays and Sundays at 1030am and every other Friday at 230pm. The committee is very thankful for those who have already signed up and are regularly attending, there is a need for additional men and women to bring Alcoholics Anonymous into the facility.

All of this and much more can be discussed at our next committee meeting held on October 24th at 8pm in our District zoom room.
