- 1. we will be amazed before we are half way through.

- 8. No matter how far down the scale we have gone, we will see how our experience can benefit others.

- 18. We will suddenly realize that God is doing for us what we could not do for ourselves.

**1.** We made the list when we took inventory in the 4th step. (BB page 76, L19)

**2.** If we haven't the **will** to sweep away the debris which has accumulated out of our effort to live on **self-will, we ask (God) until it comes.** (BB; page 76, L24)

**3.** We may feel **diffident** (lack of confidence) about going to some of them on a spiritual basis. To some we need not and probably should not emphasize the spiritual feature **on the first approach.** (BB; page 76, L30)

**4.** Our real purpose is to fit ourselves to be of maximum service to god and the people about us. (this is the main purpose of A.A.) (BB page 77, L3)

**5.** With the person we dislike, we take the bit in our teeth. It **is harder** to go to an enemy than a friend. (BB page 77, L24)

**6.** Under no condition do we criticize or argue. **We will never get over our drinking until we have done our utmost to straighten out the past.** (BB page 77, L29)

**7.** If our manner is **calm**, **frank**, **and open**, we will be gratified with the results.

**8.** If thrown out of "his" office, we have done our part. It is water over the dam.

**10.** We **must** lose our fear; we **must** not shrink at anything; we **must** keep sober; we **must** take the lead; we **must remember:** (BB; pages; 78, 79,80,82,83 :)

**11.** Good judgment, a careful sense of timing, courage, and prudence - these are the qualities we shall need when we take Step Nine. 12X12; Pg. 83.

- 12. Types of Amends: (12x12; Page 83)
- There will be those who ought to be dealt with just as soon as we become reasonably confident that we can maintain our sobriety.
- There will be those to whom we can make only partial restitution, lest complete disclosures do them or others more harm than good.
- There will be other cases where action ought to be deferred,

and still others in which by the very nature of the situation we shall never be able to make direct personal contact at all.

Most of us begin making certain kinds of direct amends from the day we join Alcoholics Anonymous.

**13.** It's not in the Basic Text(s) but sometimes we here the term **"Living Amends"**, which is referring to the last line of the 12th Step: .."practice these principles in all our affairs."

**14.**Or we may just procrastinate, telling ourselves the time is not yet, when in reality we have already passed up many a fine chance to right a serious wrong. *Let's not talk prudence while practicing evasion.* 12X12 pg. 85

**15.**..at some point we will want to summon all our courage, head straight for the person concerned, and lay our cards on the table. We needn't wallow in excessive remorse before those we have harmed, but amends at this level should always be forthright and generous. 12X12 pgs. 85&86

**16.**But all of them do require a complete willingness to make amends as fast and as far as may be possible in a given set of conditions. 12X12 pg. 87

**17.** Above all, we should try to be absolutely sure that we are not delaying because we are afraid. For the readiness to take the full consequences of our past acts, and to take responsibility for the well-being of others at the same time, is the very spirit of Step Nine.

**18.Step 8 is the beginning of the end of isolation from our fellows and from god.** (12 & 12 page 82)

**TWO WEEKS**\_Six (Updated by Ed.)weeks from this weekend members of Alcoholics Anonymous, Al-Anon Family Groups, and Alateen will have an opportunity to gather in Lisle Illinois at the Wyndham Hotel and Conference Center for the 37<sup>th</sup> Annual Illinois State Conference. To date, we have achieved 15% of our break even goal for registrations, (93), 23% of banquet registrations (70). Our goal is 600 conference registrations and 300 banquet registrations. We also need 225 hotel room night registrations. As of Tuesday we had 66. We have recently returned \$1000 to NIA, and made a final \$750 deposit payment to the Wyndham prior to July 1st.

This qualifies as crunch time for the conference. In the interest of our common welfare, your planning committee humbly requests that you consider registering for our conference, banquet, and hotel room well before July 23<sup>rd</sup>, when we need to tell the Wyndham Hotel and Conference Center if we need to decrease our room block by a maximum of 20%. In order to fulfill our commitment to the groups of Alcoholics Anonymous in the State of Illinois and its 3 Delegate Areas, there remains a huge need to stick with our original goal of 600 conference registrations and 300 banquet registrations.

Voices of District Shares on Steps 8 & 9

**I** was the one who was sober for maybe 2 weeks (which was huge for me) and wanted to apologize to everyone for anything I did wrong. What it was exactly, I wasn't clear on yet but I had to apologize anyway. I hadn't been myself in so long and I felt alive and wanted to make the wrongs I knew of right. I relapsed every 2-3 weeks like clockwork so those perky apologies were nothing but broken promises and I was more alone that ever.

When I finally chose the lucky person that would be privy to all my darkness, I began to tell her how I was going to work the steps and in what order. I would have to write an amends letter to 2 very dear people that won't be in my life and it was tearing me up. She of course, suggested I wait but I went ahead because I had to, they would forgive me, my best friend of 26 years and my favorite client. It was not to my benefit. They are two people who have moved on with their lives without me in it and it has taken years for me to accept that. Heartbreaking. Listen to your sponsor and do your steps in order, that is what was pounded into my head.

Today I am currently on step 8 going on 9 and I will write what I want to say to each person on my list, say it out loud to my sponsor for feedback and reassurance and make a date to meet up with each person. I get to look them in the eye today and mean what I have to say. Asking forgiveness is awesome and being forgiven is better yet. What a gift, clearing up the wreckage of my past and my present too!!! ## Some Details About Self-support

Date:25 Jun 2010-FROM OUR DELEGATE Ladies and Gentlemen:

Several questions concerning the current financial status of Alcoholics Anonymous have been sent on to me in the last few days. To answer those questions as broadly as possible, I offer the following. Please forward this email on to any who may be interested.

*I*h 2009, the cost of services provided by the General Service Office to your Home Group and to carry the message to the still suffering alcoholic in the United States and throughout the world was \$6.46 per member. Contributions received by the General Service Board to support this effort were \$4.50 per member (from the US and Canada). Contributions by the Fellowship in Northern Illinois in 2009 were \$3.56 per member - more than 20% lower than the overall average - with only 40.6% of our groups making contributions – again, almost 10% below the overall average on a percentage basis.

At the 60<sup>th</sup> General Service Conference, our Treasurer thanked all who had contributed to the support of AA's efforts to carry the message in 2009. In fact, overall contributions were down 2.5% from 2008. Total Area 20 contributions dropped from over \$96,000 in 2008 to under \$79,000. We are fortunate that this drop in contributions by the Fellowship was made up for through the purchase of literature primarily by non-AA entities. Hazelton, Borders and others made large purchases in anticipation of last year's July 1 price increase for the Big Book from \$6.00 to \$8.00. The purchase of literature by non-AAs increased from 20% of all books sold in 2008 to 30.6% in 2009. Increases in overall revenues in 2009 were primarily due to these pre-price increase literature purchases by non-AAs. As a result, our Reserve Fund balance at the end of 2009 remained at approximately 9 months of operating expenses – the low end of the acceptable range as previously determined by our Conference.

*C*ontributions through May 31, 2010, are essentially flat compared to those of last year. Of concern this year are the lagging literature sales. While such a decrease was anticipated to an extent in budgeting for expenses for this year, total distribution of all books for the 5 months ending May 31 is down 22.7% from the same period in 2009. Literature sales are down by \$778,174. At this point, June sales are not expected to be any better. Reasons offered for the slow sales are: 1) overall economic conditions, 2) the lack of the need to restock by those entities that bought in bulk prior to last year's price increase, and 3) hard copy purchases and downloading of the Big Book and other literature from entities other than AAWS, Inc.

f we continue to rely on sales of literature rather than digging into our individual pockets, one of two things can be expected. First, the cost of literature so vital to carrying the message to those still suffering behind the walls, in treatment facilities and as they walk in the doors of our Home Groups will continue to increase. The ability of our service committees and Home Groups to afford the very literature which they use to carry the message will be affected. Alternatively, the General Service Board's ability to carry out our directives to provide services to support carrying the message within the United States and throughout the world may be affected. The Board and the General Manager will be compelled to make choices concerning the services to be provided. Last year, it was discontinue publishing necessary to the regional directories for a year and to defer filling one staff position, among other efforts to cut costs by more than \$660,000.

The amount you and I put in the basket at meetings we attend covers not only the basic costs of that meeting and group but also the cost of supporting efforts to carry the message by local service committees and the General Service Office acting on our behalf. As was announced at Saturday's Assembly, it is now possible to make an online contribution directly to the General Service Board either individually or on behalf of your Home Group at <u>www.aa.org</u>.
