# 'GIMME DIED LAST NIGHT'



### "GIMME DIED LAST NIGHT!"

That was just one of the phrases that ended up on my grudge list under "principles" for my 4<sup>th</sup> Step. My "Coal Miner Uncle", who raised me from age 12, said that to me often even though I didn't understand what it meant.

I found out in A.A. that "Gimme" was my prerequisite desire for traveling the road of self-will-run-riot!

In Step 4 and 5 I learned that the exact nature of my wrongs was, where had I been selfish, dishonest, self-seeking, frightened & inconsiderate. (Grosser Handicaps)

To keep it simple when I got to Step 6 & 7 the 1<sup>st</sup> time, did I find those Grosser Handicaps Objectionable? Was I ENTIRLELY ready to have God remove them? That was all the was required; did I finally see their destructive nature?

When I was ENTIRELY ready, I entered in to Step 7 and humbly asked God to remove them.

The Grosser Handicaps are the "catch-all" of character defects and shortcomings; any defect will "fit" into one of those five, again to keep it simple at this point.

The Spiritual Awakening or Experience is already taking shape.

Then we enter Steps 6 & 7 and understand the Grosser Handicaps & are entirely ready to have God remove them & humbly ask him in the 7<sup>th</sup> Step prayer. (Prayer - **BB**, **page 76** 

## **Wonderful!!**

We continue on through the remaining steps and life seems better than it has been in a long time or the best ever. ("IT" still continues to get better & the "IT" is me, providing I....)

Frequently, I was still struggling with my character defects. I've tried so many ways to get rid of them, and they're still there.

## I was a 10th Step Junkie – but still...

Something's not working I thought. What am I doing wrong?" There seems to be a persistent feeling of uneasiness in spite of sincere efforts to work the program. I had done careful Fourth and Fifth Steps, but am **still not finding** the peace of mind that indicates serenity.

They sense that something was missing, something wasn't right, but I didn't know what it was. Doubt crept in, and I began to feel inadequate and discouraged about the program of recovery suggested by Alcoholics Anonymous.

With the aid of Step 11 when evening comes, perhaps just before going to sleep, many of us draw up a balance sheet for the day –


Step 10 would ask me if my RECOVERY was solid so far? Are the CONERSTONE AND KEYSTONES properly in place? Have I skimped on the WILLINGNESS put into the foundation of my recovery? Have I tried to make mortar without sand – getting results without any action? and to make note of where I was coming up short.

## That would direct me back to Step 6 where I had a CHOICE.

Was I entirely ready to have God removed my shortcomings experience this day or not? If so, I would go onto Step 7 and Humbly ask God to remove them. (Part of my nightly 11<sup>th</sup> Step when I drop those shortcomings into my 3<sup>rd</sup> and 7<sup>th</sup> Step Prayers)

If we are sorry for what we have done, and have the honest desire to let God take us to better things, we believe we will be forgiven and will have learned our lesson. If we are not sorry, and our conduct continues to harm others, we are quite sure to drink. We are not theorizing. These are facts out of our experience.

I attended the Spring Committee Meeting at the Lord of Life Church in La Fox, IL. on May 12th.

Discussion of NIA Committee Agenda items were:

#### 1. Motion by Are Alt. Delegate for Participation in non-hosting State Conferences

To cover the anticipated cost of reimbursement for participants in the Illinois State Conference when not hosted by Area 20, the Area Alternate Delegate moves that the following modification be added to the Primary Purpose Register and that the Area Treasurer be authorized to reimburse expenses in accordance with the terms of that entry:

Projected cost \$2800.00

#### 2. Motion by Electronic Equipment Committee for Projection Equipment

The Electronic Equipment Committee moves that the following entry be added to the Primary Purpose Register and that the Area Treasurer be authorized to reimburse expenses in accordance with the terms of that entry:

Projected cost \$300.00

#### 3. Motion by Finance Committee to Support East Central Regional Panel

To fulfill a request to bring a panel to the East Central Regional Conference/ Michigan State Conference in Grand Rapids Michigan on the weekend of June 29 - July 1, 2012. The Delegate requested funding so that interested panelists would not have to cover their own expenses to do this work. After consideration, the Finance Committee unanimously recommended approval of this request, increasing the projected cost from the \$800 to \$1,200 reflecting the possible involvement of four panelists.



One of the potentially frightening aspects of working Steps Six and Seven is that they require us to deal directly with God. We are left alone to communicate directly with our God; to look at our relationship with Him in the privacy and loneliness of our own hearts and minds. Very frequently, this problem arises not because we do not want to work these Steps, but because we don't know how.

It is to be expected that these Steps will be especially formidable to anyone who has not yet accepted the presence of a Higher Power. Even those with a solid faith in their concept of God and a strong religious upbringing sometimes have difficulty accepting the simplicity of these Steps. Early religious training may have taught us that we must be "good" if we expect good things from God. There is a feeling that we have to "measure up" before God, that we must "clean up our act" before we can go to Him in prayer. Maybe there is even a fear that if He knew us as we really are He couldn't possibly want us near Him.

Are we so ashamed of our acts that we cannot bear to look at them ourselves, much less share them with such a powerful being? One must wonder if these feelings aren't present when we pray like this:

"Dear God, I want to be more honest."
"Dear God, I want to have more patience."
"Dear God, I want to be a kinder person."

We are praying for what we want to be, or how we think we should be, instead of simply and honestly telling Him how it really is with us. Wouldn't it make sense, when we come to God with our defects of character, to make a statement of what our condition is rather than what we want it to be?

Let us think back to our struggles with Step One: "We admitted we were powerless over alcohol- that our lives had become unmanageable." Perhaps our prayers were something like this:

"Dear God, make me a normal drinker."

"Dear God, help me to control my drinking."

"Lord, I don't want to drink like this... I want to drink like others."

These prayers made sense to us because God should want us to drink decently, shouldn't He? We would cry, "Why can't You give me this? I pray to You, yet I wake up drunk! How can there be a God?"

By now we know the answer to these prayers. Could it be that these were selfish prayers - prayers completely centered around our wants, our will for ourselves?

It wasn't until we could humbly and honestly come to Him and tell Him how it really was, until we could say to Him, "Dear God, I am powerless and my life is unmanageable," that the healing could begin. Only when the struggle and fighting ceased and the acceptance began, could the recovery process begin.

## God, Manage me because I just can't manage myself.

Coming back to Steps Six and Seven, perhaps we need to remember the problems we encountered with Step One. Maybe we need to begin our prayers with an honest statement of how it is!

"Dear God, I am impatient."

"Dear God, I am an intolerant person."

"Dear God, I do lack faith."

"Dear God, I am an unkind person."

Present Him with the reality of ourselves, instead of our dreams and wishes of how we want to be.

It is not necessary to present ourselves to God in any other way than as we actually are. We do not need to "clean up our act." It is my understanding only, this is not what God intends for us. He is telling us that we cannot do anything to earn His love, no matter how much money we give, how many good works we do, or how good a Samaritan we are. We cannot earn His love. His love is already ours through His grace alone. Grace is unmerited love and favor. It does not have to be earned or bargained for. It simply exists. That is my understanding, for what it's worth.

Whether we believe this or not depends on whether we have faith. What is faith? Simply believing in something that doesn't have to be proven. If a lack of faith is preventing us from living with some measure of peace, then it certainly qualifies as a defect - a defect that is standing in the way of recovery and our relationship with our God as we understand Him. Perhaps this lack of faith is the first character defect we can be honest with Him about.

Alcoholism is described as a threefold illness: physical, mental and spiritual. Recovery has to take place in each of these three areas and faith in a Power greater than ourselves is a vital, necessary part of that recovery. It is also important to remember that even after we have found and nourished faith in a Higher Power we need to consciously cling to it on a daily basis. Even those with a long, solid sobriety and a strong faith sometimes waiver and need to ask for strength. Working and living Steps Six and Seven must be an ongoing process. Just as a plant has to be watered again and again if it is to live, so does faith. It needs care and attention to remain strong and healthy.

Maybe this is an area in which we could make use of the willpower that was so useless to us in our attempts to stop drinking on our own. Will is simply the power to choose. We have the power to choose to do whatever we need to do to nourish our faith, no matter how tenuous it may be. God does test me but my faith is tested in Step 6 with the CHOICE. We can choose to go to meetings. We can choose to read the daily readings.

We can choose to attempt to live the Twelve Steps honestly. We can choose to go to any length in pursuit of sobriety.

### We can choose to pray unselfishly.

So it is with our character defects. We can choose to identify them, to become aware of them and accept them and, as a result, gain some measure of strength to manage them, instead of being managed by them. We can choose to share them honestly with our Higher Power, to tell it like it is and to ask His help in their removal, believing that He will remove them.

There is a solution. Almost none of us liked the <sup>1</sup>self-searching, the <sup>2</sup>leveling of our pride, the <sup>3</sup>confession of shortcomings which the process requires for its successful consummation. BB, Page 25

Three things we have to learn to accept and do.

#### STEP 6:

He goes on to explain that any person capable of enough willingness and honesty to try repeatedly Step Six on all his faults - without any reservations whatever - has indeed come a long way spiritually, and is therefore entitled to be called a man who is sincerely trying to grow in the image and likeness of his own Creator.

## **Momentum** Is important

The A, B, Cs implied that "I can't, but "God can. Being convinced of this I desperately prayed for God's assistance in Step Three.

In so doing I had asked to be relieved from the bondage of self, whatever that was! But what was it? Well, the sooner I found out, the better my chances for sobriety! The Big Book provides a timetable to illustrate the importance that I discover what had been blocking me from God's help, and find out elpronto!

"Next we launched out on a course of vigorous action, the first step of which is a personal housecleaning, which many of us had never attempted. Though our decision was vital and crucial step, it could have little permanent effect unless at once followed by a strenuous effort to face, and to be rid of, the things in ourselves which had been blocking us. Our liquor was but a symptom. So we had to get down to causes and conditions." (P. 63 – 64)

The word "launched" doesn't sound like hitching up the horse and buggy, but more like kerooming off in a rocket ship. . . . And we are instructed to do this "at once," or our Third Step Prayer will have little permanent effect! Now this I can readily understand. When my home team wins or loses our football game I often embroider feelings of tremendous joy or despair, but two weeks later barely a tinge of that previous emotion or even memory remains.

If momentum is of essential importance, then timing is of essential importance! Luckily, for me, my sponsor, Carl, started me on the Step Four process within just minutes after praying the Third Step Prayer – with deep emotion, I might add. Consequently, just as the Big Book says, I had a great effect! Momentum! Now, years later, I still maintain the great effect!! It is as though I prayed the Step Three Prayer with Carl just yesterday.

The Big Book directions indicate timing, which perpetuates sufficient momentum to fully benefit from the Step Process, e.g.: Step Four, at once; Step Five, at first opportunity; after a period of reflection, Step Six is "then," (not later); Step Seven, when ready, Step Eight is already done (We did it when we took inventory - p. 76); and Step Nine begins now, but may take months or years to complete the list. Steps 10, 11 & 12 begin as soon as the Seventh Step prayer is finished. (See page 84 and read ". . . set right new mistakes as we go along.") It doesn't say after Step Nine amends are completed. Please note the many timing/momentum suggestions of the Maintenance Steps.

I thank God for a sponsor who knew the importance of momentum!
