When people visit they ask if she has one to read. They have one for the volunteer but she does not want to give his away in case it gets lost.

It is not just a homeless shelter. They have services from Thresholds, Family Alliance Comprehensive Care Service and Home of the Sparrow there. The intention is to guide them out of homelessness. There are people staying sober there.

The Center is open Tuesday, Wednesday and Thursday, 9AM-3PM. The article quoted someone there saying people are trying to stay sober there at their Wednesday meeting. It has been open for a year. They get a shower, some food, haircuts, etc.

I called Bob Kleinfelter and he is going to make a visit to the facility next week.

In the meantime, I bought three Big Books and will try to get them to her Thursday.
