DCM Report: Carol H. DCM, OPEN. Alt DCM

The Pre-General Service Conference Workshop was held Saturday April 11th at the Lord of Life Church in LaFox. District 11 hosted this workshop by providing volunteers to sit at the registration table to offer lunch to participants for the minimal cost of \$8.00. Mary F. and Margie were nice enough to volunteer their time and collect and account for almost 60 lunches while Pat C. and Bob M. help set up coffee and a continental breakfast. Since we were low on volunteers a few members from District 12 offered to help by acting as guides to the many breakout rooms where each NIA service committee met to discuss a particular agenda item usually relating to their area of service. Lunch consisted of chicken tetrazzini, salad, a pasta primavera, rolls, and dessert. The reason that I give you all this detail is because most of you were not there to find this out yourself. To me this is one of the most important NIA or district meetings of the year, the one time we are asked to share our group conscience and be a part of AA and out of the 150 meetings that are held in McHenry County and District 11 there were the same 4 to 5 groups that were represented. We planned for 100 lunches and barely paid for 60, last year we planned for 130 lunches and had 100. The number of alcoholics doing the suggested service responsibilities for OUR groups is dwindling. Pat C. led the Corrections session and not one Corrections chair from the whole area attended. That is sad. So ask yourself, are you a part of AA and how do you see this fellowship and organization continuing.

Unfortunately I was so busy setting up rooms and lunch that I did not get to participate in much of the discussion, only sitting in on the break-out session for Treatment and Special Needs. Although there were just a handful of us we had a lively discussion about a recommendation that we made to clarify in the Treatment workbook the difference between a Bridging the Gap (BTG) program and a meeting held in a Treatment center which is commonly referred to as a Bridge the Gap meeting.

Fortunately I know that first hand as I was privileged to attend the first Bridge the Gap meeting a Share in Hoffman Estates on Monday and help provide temporary contact to a woman returning to her home town in Equality, IL the very next day. Our own District 11 member and past delegate Rich H. has been very active as the newly appointed BTG Chair for Northern Illinois and was contacted by this facility to start a program that has been absent for 11 years. Fortunately the Treatment/BTG committee from District 22 will be sponsoring this on a bi-monthly basis and have worked out the details of providing assistance to the current treatment patients

when leaving the facility.

I attended the 2016 State Conference pre-planning meeting on Sunday April 26th with the DCM for District 10 Chuck D. and the DCM Bill E. and Alt DCM Carl T. of District 28. Basically we discussed the agenda for our first planning meeting to be held at the Lake Zurich Police Department on Sunday May 17th at 1:00pm. We will be discussing the duties and responsibilities for each committee and electing chairs and their alternates chairs to begin our year and half-long journey. We are very fortunate to have the experience of being part of many conferences just between the four of us DCM's and others that we have worked with on prior planning committees have expressed their intent to get involved with next year's event. In addition to that we also have the area advisory committee to assist with hotel selection and contract negotiations so our past delegate, Ray M. and Marcia S. will share prior experience with the planning committee. Cheryl V., our current delegate, and Robert S., our current Area chair, will also be part of the planning process and provide their expertise and help in any way necessary. But we will need many hands to effectively plan this statewide conference. I hope you will be a part of this event and would like some of you to be there when we begin by attending the first planning meeting of the 2016 Illinois State Conference.
