Balance Sheet

The balance sheet report, updated through September 30, 2018, is attached.

- Our bank balance was \$31,730.59
- Our restricted funds were \$9,271.25 which consists of:
 - o "Pink Can" funds of \$9,014.12
 - o "Green Can" funds, of \$257.13
- Our Prudent Reserve funds were \$16,657.05
- Our Conference checking account balance was \$2,425.91*

*Note: This account is not reflected in QuickBooks, so it is not included in the balance sheet. This account has been turned over to the 2019 IL State Conference Committee and the ownership was just completed so the funds will be moved back to the NIA checking account.

Contributions/Expenses (Profit and Loss in QuickBooks)

The QuickBooks profit and loss report show the following year-to-date totals as of September 30, 2018:

- Resulting in a Negative Net Operating Income of (\$10,915.60)
