Step 1 -

## We admitted that our lives had become unmanageable...

Somewhere in the dark recesses of my mind I always knew I had a problem with drinking, but I didn't have a clue how to do anything about it. I was extremely selfish and self-centered. What use would you be to me? "Hey man, buy me a beer? Let me get a hit? Do you have any work for me?" I always thought that as long as I had a job that everything was going to be all right; for the moment anyway, until I lost another one. I picked a line of work that was always available and had a high turnover rate. If I couldn't get along with the boss or just got bored with it I'd quit. I'd tell myself "That's o.k., I'll find another one." Most of the time though, I would lose jobs due staying out all night drinking and then not being able to get up the next morning. I would try to rationalize it by telling myself maybe I'll have to give up smoking pot or

drinking. I knew that I couldn't do both anymore. I was sleeping through my alarm or would just reach over and turn it off. I decided that I would quit smoking pot. That would fix the problem right? Wrong, I still couldn't see the real problem. I was in denial.

A pattern started to form. Not only could I not hold down a job but also the same went for relationships. It stands to reason that if you don't have a job you have no money, a place to live or the confidence needed to find someone. If that wasn't enough, I would just end up getting belligerent, saying something stupid or just get downright mean and that would usually end it. Somehow I was always able to sweet talk someone into feeling sorry for me or convincing them that I was in love with them just so I would have a place to stay for awhile. You know, just until I can get back on my feet.

That was fine with me while I was still in my twenties but as I got older I started to ask myself why I couldn't find that certain someone, settle down and raise a family. These were things that I had always wanted.

Years later I finally found someone that I wanted to spend the rest of my life with. Although I quit smoking pot about ten years ago I was still drinking and she took notice. At first it was "Maybe you shouldn't drink so much after work," to "How about you only drink on the weekends?" to "I've done some research and I think you might be an alcoholic." WHAT! An ALCOHOLIC! Not me, you've got the wrong guy. This started a resentment. I knew that she could have a couple of drinks and walk away and as much as I wanted to be like that, I knew I would never be. "I'll show her I told myself. I told her I was only drinking non-alcoholic beer and that's why she smelled it on my breath. I could look her in the eyes and talk to her without her knowing I'd been drinking. If I stayed out late enough she would be asleep when I got home. I would tell her I fell asleep on the couch. This worked for about a year and a half. Then it finally came time to face the music.

I was driving home from a poker tournament so drunk that I blacked out behind the wheel, lost control of my car and totaled it. This was the day my life changed. The people whose yard I destroyed helped me out of the car and invited me into their home to sober up a bit. They said not to worry about the police; they weren't going to be called. If that wasn't enough they asked me if I wanted to leave my car next to their barn and they would give a ride home. I accepted. There was only one problem with this; it was only about 9:30pm. and I knew that I would have to face my wife when I got home. There would be no getting out of this one.

We decided that counseling was the only option. It was the best-case scenario for me. At least we weren't talking divorce. Later, she told me this was an option but I couldn't blame her. For the first time in my life I was starting to learn what love was but if I couldn't even love myself, how was I going to love someone else? I was ready to do whatever it would take to save our relationship. It was only our first visit and about half way through the caseworker stopped us. He said, the problem wasn't our marriage, it was my drinking. It took a complete stranger to tell me that I was an alcoholic! With this I broke down. I was ready to surrender. I found out later that he was also in the program and been sober

for 28 years. I signed myself up for outpatient treatment and few days later I walked through the doors of A.A. I was powerless over alcohol!

A power greater than ourselves could restore us to sanity...

I choose to call him God. None of this could even be possible for me without Him. My accident that night brought me to the program and the program brought me to God. Funny how life works huh? This all brought me to believe that there aren't coincidences only the way my Higher Power thinks it should be. When I started to believe that, my life got better. What He has done for me is immeasurable. He has giving me the ability to communicate my thoughts and feelings. To take that step back and think things though before I act out. These things were never possible for me because I would always be two steps ahead trying to control outcomes. I would jump in and deal with the consequences later. The sanity was restored for me when God allows me to stay out of my own head. I know that every time I ask for His help it is given to me. Calmness comes over me and I know everything is going to be all right.

I think I am finally starting to understand what this program is all about. Don't ever be embarrassed or ashamed to ask of your Higher Power (or anyone in the fellowship) for help. You will always receive what you need to hear, as long as you are honest, open and willing. If you take it one day at a time, remembering to do the footwork, with the help of the fellowship and your higher power, life will continue to improve and your sanity will be restored. GODSPEED!



#### The Search for Power

When I was drinking, I knew my life was unmanageable and I blamed the world for my problems. I went to great lengths to try and "fix" the external aspects of my life – getting in and out of relationships, geographic moves, changing jobs, diet and exercise, etc. None of the external changes had much effect on how I felt on the inside and my disease continued to progress.

I was brought up to use will power to solve problems and to follow the motto "if at first you don't succeed, try and try again". I tried every method I could imagine to control my drinking and was devastated by my failures. I believed that I was worthless and that life was a continuing succession of pain. The only relief I could find came in a bottle or pill. I maintenance drank during the day, binge drank at night, and drank myself back to sleep when I woke before morning.

I came to Alcoholics Anonymous in a bad mood! I read the steps, imagined in my mind what they were about, and decided which ones were necessary for me. I was willing to accept the second half of Step 1, "that our lives had become unmanageable" but didn't think the remainder of the Steps applied to me. I had special and unique problems requiring a special and unique solution.

My special and unique solutions at sobriety failed as badly as my attempts to control my drinking. I gradually realized that the people I met in AA knew the same feelings of fear, self loathing, helplessness, and anger that were ruling my life but that they had found ways to deal with those issues. I finally admitted the first half of Step 1 was as true as the second half. I didn't have the power to cure my disease but I continually associated with other alcoholics that had been restored to sanity by following a path I had yet to try. I came to believe a power greater than myself could restore me to sanity. I eventually began working the steps of Alcoholics Anonymous with a sponsor and have benefited greatly from working with people who have the qualities in life that I seek.

## Step One - Powerlessness & Unmanageability:

To admit I was powerless over alcohol meant I was weak; I had a fault, that something dominated me. I couldn't do it...for so long...for years. I stuffed that thought so far down in me. How was I going to say I can't drink anymore, which meant my life as I knew it was over. It was too much. It was too overwhelming. It frightened me more than anything I have ever been asked to do before in my life. But something happened, I had hit my bottom, a place I pray I don't' ever have to go back to; A place that is always waiting for me if I put a drink to my lips. I finally came to a point in 2006 where I made a phone call to an AA member, a stranger. All I heard was "Are you ready", "Are you willing" and somehow (I now know it was a power bigger than me), I heard the words "Yes" come out of my mouth. That is the day I'll never forget nor will I never stop being thankful for. It is the only part of my AA program to date that I feel I have done 100%....

"And that our lives had become unmanageable", when I heard that for the first time, I (like any other "unique alcoholic"), thought I had some room not to really dig so deep. I had a "normal" life; 10-yr relationship, roof over my head, 2.5 cars in the garage, went on vacations, had a job, etc. Now let me dissect that.... My relationship was never deep & meaningful, the roof was not mine, the car payments were way overdue, never paid for the vacations, and oh yeah, and I just got fired for doing drugs & alcohol at my job. Yes, it took me working my sponsor, going to meetings, and working this step to redefine in my delusional mind what the definition of manageable meant and what it means to me today. To me today, it not entirely wrapped up in all the material day to day stuff, it's the manageability of my life inside myself.

### **Step 2 – Came to believe in a Power** that could restore me to sanity...

This step was both easy and difficult. My first response was that this preconceived dogma "God" that I was raised on, needed to enter my life again. I resisted this with all I had, with all due respect to that religion. But thru going to meetings, keeping my mind and thoughts open, I felt this surrender inside of me, wanting so much for my life to change, and again something started to happen. This "sanity" that I was hearing about, this "Higher Power greater than myself", this restoration, did start happening to me. It was and is amazing to this day. It is no longer all up to me. There was a pressure relieved, a weight lifted that I really didn't know I had been caring around with me until it was gone.


