02/13/25 - Legacy of Service: Concepts Study - Another month of no attendees.

03/02/25 NIA (Northern Illinois Area) 20 Spring Assembly – I attended the Northern Illinois Area 20 Spring Assembly virtually. We heard, discussed and approved a floor motion to contribute \$200.00 to the East Central Region's hospitality slot at the 2025 International Convention.

We also heard from the Treasurer that NIA20's books were balanced as of December of 2024, and that our current YTD expenses have exceeded our contributions by \$7,356.23. It should be noted that there was a \$1,700.00 discrepancy that is being looked into. Most likely just a QuickBooks error. NIA20 Registrar Rob M. stepped down and Kim D., the Alternate, per our legal bylaws, stepped into the position. We elected a new Alternate Bridging the Gap chair, and a new Alternate Registrar.

During the DCM breakout we discussed the importance of the Pre-General Service Conference Workshop to the new DCMs and went over the schedule of the zoom breakout sessions leading up to the workshop. The workshop will be held Saturday April 5 th at the Dixon Elks Lodge #779 at 9AM, in Dixon, IL. I would advise going in person as I learned Saturday that Zoom can have some technical difficulties when not at Lord of Life.

The Spring Committee Meeting will be held May 10 th at Lord of Life in Elburn.

On Saturday, March 1st, I attended the Spring Assembly. These are my updates. On March 24th, NIA20 Literature Chairs will participate in the PreConference Workshop. We will be reviewing items on the General Service Conference Agenda, including:

- 2. Progress report on development of the 4th edition of the Spanish Big Book
- 3. Review progress report on 5th edition Big Book, currently set to be released early 2026. (Reminder: only the stories will change.)
- 4. Discuss the Plain Language Big Book review process.
