 - We could limit the numbers to suicide only if its felt that strongly, because there are suicidal alcoholics
 - Does this info show up on NY site
 - Not sure
 - Was there a group who brought this up or was this an individual's idea
 - This came from a group discussion and was going to be brought to area
 - At last meeting we were to take them to our groups so are we voting or our group or us personally
 - GSR's are representative of their group as a whole and best for AA
- DISCUSSION:
 - 2 Huntley groups represented. Tradition 4 / 6 / 10 and affiliation Question raised "What does GSO say about it"? We are in favor provided there is a limitation, also should we consider homeless, diabetes, etc. We need to create a limit of sorts.
 - DFL Not in favor and does believe the info would be available for people who answer phones. This would be more anonymous than putting it on our site
 - About 10 years ago, the suffering alcoholic has many suicides. Has 3 he knows of in the past year and thinks we are here to help the suffering alcoholic

- Answering service would be happy to accept this information and supply it to those on call.
- In past when on answering service we had a binder to use. What to day, what not to say, and resources.
- Recommended again to contact GSO to find if they have guidelines.
- Tradition 4 not affiliate itself with anyone else. We would love to help everyone but once we start it will get so big and we would soon die.
