Carefully reading the first five proposals we ask if we have omitted anything, for we are building an arch through which we shall walk a free man at last. Is our work solid so far? Are the stones properly in place? Have we skimped on the cement put into the foundation? Have we tried to make mortar without sand?

J & C And once again we are referring to the wonderfully effective spiritual structure, the personality change we're building.

Step 1 - Willingness was the foundation (pg. 23, par. 5)


Step 2 - Believing was the cornerstone (pg. 47, par. 2)

Now surely, surely in Step 4 and 5 when we looked and we saw that old selfish, dishonest, self-seeking, frightened, inconsiderate character that we have become, when we saw that those were what cause us to do the things that hurt people. They in turn retaliate, we in turn resent, we're afraid, we're filled with guilt and remorse, causes us to drink then surely those things in the fifth column have now become objectionable to us. Are we ready to turn them lose, if we are we're thru with Step 6. The book recognizes though that **self cannot always overcome self** cause it says <u>if we're not ready</u> we ask God to help us be willing to turn these things loose.

Now you would think when we see what they do to us we'd be more than willing, but sometimes we're not. You know we human beings are funny people; sometimes we would rather sit in today's pain and suffering cause we've come to learn how to take care of that.

Sometimes we'd rather sit in today's pain and suffering than take a chance on changing in the future cause we don't know what change will bring

If I have to get rid of my selfishness and become unselfish, then how am I going to get what I want in the future?

If I'm going to have to get rid of my dishonesty and start operating honestly, then how the heck am I going to make a living? I don't know nothing about honesty when I get here.

If I'm going to have to <u>start getting rid of my self-seeking and frightened character and start operating on courage</u> that scares the hell out of me. I don't know nothing about that.

If I'm going to have to <u>start considering other people</u> <u>and their needs and their wants</u>, then who's going to take care of me?

Sometimes we would rather sit in today's pain than take a chance on changing in the future.

And the Book recognized that and said if you're not ready, we ask God to help me be willing.

J & C And with God's help we become willing with (Steps) 3 through 6. When ready we say something like this, (Step 7 Prayer)

Big Book, pg. 76, par. 2

My Creator, I am now willing you that you should have all of me, good and bad. I pray that you now remove from me every single defect of character which stands in the way of my usefulness to you and my fellows. Grant me strength, as I go out from here, to do your bidding. Amen.

J & C We've then completed Step 7.

Are you ready to have God remove them? (defects of character). If you are you're through with (Step) 6. Have you humbly asked him to take them away? If you have you've done Step 7.

But I hope you don't make the mistake I did. I assumed that now that I'm ready, and God being all powerful, that all I've got to do is turn to God and say okay God here I am, warts and all, does that mean give me the \$29.95 special and I'll never have to worry about this stuff again. I found out it don't work that way.

God will do for me, what I can't do for myself. I simply do not have the power to remove a character defect - only God has the power.

God will not do for me, what I can do for myself. And what I can do for myself is find out the opposite of that character defect, and then with God's help and all the willpower I can muster, in every situation it comes up, try to practice the opposite.

Cause you see God can't take away my selfishness and leave another (w)hole in my head. It's going to have to be replaced with the opposite, which is unselfishness. And when I first got here my mind was a set of mental habits ingrained in 38, 39, 40 years of living. The habitual thing for me was to react selfishly.

The only way to break a habit is to work against yourself.

If I ask God to take away <u>selfishness</u> and I start trying to practice <u>unselfishness</u>, then slowly the old habit dies and a new habit takes its place.

And over a period of years I have become an unselfish human being. I am not what I was when I first got here. If I want God to take away <u>dishonesty</u>, then I must do my part, which is to practice <u>honesty</u>

in every situation that comes up and that's hard for me to do. That is so alien to my nature that I can't practice honesty without Gods help. But with God's power and all the willpower I can muster I can force myself to be honest and slowly the old idea dies and a new one takes its place. The habitual thing for me today is to react to any situation with honesty.

If I want God to <u>take away fear</u> then I've got to kick myself in the butt and practice courage.

If I want Him to take away <u>inconsideration</u>, then I must start <u>considering other people and their needs and their wants</u> and slowly the old idea dies and a new idea takes its place. (*Continued on page 3*)

J&C I am not what I used to be. Now I'm not completely unselfish, never will be. I'm not always completely honest. Sometimes I'm afraid and other times I'm inconsiderate but the majority of the time I'm an unselfish, honest human being with courage, considering other people first. You know I think you and I are the luckiest people in the world. We have the opportunity through these two little steps right here (6 & 7) to live two lifetimes in one lifetime. Most people out there are sick; most of them are going to their grave sick not even knowing they're sick. We not only know we're sick we know what's wrong with us we found it in Steps 4 & 5.

And in 6 & 7 we can do something about it and we can change it and we become entirely different human beings.

Most people don't get that opportunity. Now be careful, for God's sake be careful, cause if you really accept this as the correct thing and the right thing then that means from this day on_you are responsible for what you are. I can't blame it on Barbara any longer, I can't blame it on Mother and Dad, I can't blame it on God and I can't blame it on society.

If I stay selfish, dishonest, self-seeking, frightened and inconsiderate it's got to be because that's the way I want to be.

I no longer have the luxury of blaming it on others cause I don't have to be that way. You know what I found out? I found out that when you become <u>unselfish</u> people start kinda liking you a little better than they did before. I found out when you start becoming honest well you feel better about yourself.

That's the way you build self-esteem is to do the right thing for a change

I found out when I practice with <u>courage</u> and I operate on courage instead of <u>fear</u> I do things that makes me fell better and I quit doing things that made me feel so bad.

I found out there's real pleasure in <u>considering other people first</u> <u>and</u> giving to others before you take for yourself.

I didn't know that. How in the hell could I know that, I've never been that way before. This thing really amazes me in what happens to us and the simplicity of this thing if we'll just do what the book says. Joe?

You know there's always a paradox in AA.

To give you an idea what a paradox is how many of you have ever called you're sponsor so you could listen.

We always call him so we can talk, right? That's the paradox. And the paradox here in these two steps is that they use the Doctors Opinion (p. xxiii) and the first four chapters to do Steps 1 & 2; 3.5 pages for Step 3. 8 pages for Step 4, 4 pages for Step 5, and a whole chapter devoted with "Working with Others". Bob P. 2014 NIA Spring Conference Chair made report:

Next planning meeting is May 12th, 2013 at 2:00pm at the Waukegan Alano Club. Committee will meet on second Sunday of the month. The agenda will include: voting on open committee positions, selection of conference theme, and selection of central meeting location for committee.

The 2014 Spring Conference will be held in March. The hotels which are under consideration are the Holiday Inn in Gurnee and the Hyatt Woodfield in Schaumburg.

The committees to serve on are Program, Registration, Alcathon, Archives, Printing, Coffee, Public Information, Decorations, Entertainment, Hospitality, Banquet, Grapevine, Greeters, Literature, and Special Needs. Committee chair positions are still open for Public Information (chair and alt.), Printing (alt.), and Grapevine (chair). Much help will be needed on all the committees and work needs to start on flyers and registration forms. The goal is to have flyers ready for the East Central Regional Conference in Appleton, WI on the weekend of July 19th. Another goal is to have a registration table at the Area 20 assemblies.

Rich H. (Area Delegate Visit -) & made PGSC report:

As Area 20's delegate, Rich attended the General Service Conference in New York. This was his second time reporting to the GSC and his last. At the district meeting, Rich discussed specific Advisory Actions, Additional Committee Considerations, Recommendations which did not result in Advisory Actions, and Floor Actions which did not result in Advisory Actions that he found to be of interest.

The following Advisory Actions were voted on as such:

- 1. A commemorative 75th Anniversary Edition of the first edition, first printing of *Alcoholics Anonymous* be published in April 2014. This action was passed with a majority vote.
- The draft pamphlet "A.A—Spiritual not Religious" be recommitted to the trustees' Literature Committee for additional discussion and brought back to the 2014 Conference Committee on Literature. A change of title was discussed as well as the adding to the thirteen stories.
- 3. A.A. World Services be permitted to utilize digital channels and current (commissionable) support and distribution technologies, such as, but not limited to, smart phones, tablets, e-readers, applications and commissioned online stores for the sale and distribution of digital A.A. literature. The committee requested that the board ensure that all contracts protect our Traditions, with the option to discontinue any and all contracts at any time. The committee requested that a status and financial report be submitted to the appropriate 2014 Conference Committee. No one contributed to the discussion of the topic and it passed by almost 100% votes.
- 4. Bill F. from Ohio was voted in as the East Central Regional Trustee.

The following Additional Committee Considerations were brought up:

- 1. The committee requested that the GV board submit a proposal to the 2014 Conference Committee on the Grapevine that would significantly reduce the La Viña deficit.
- 2. The committee reviewed the results of the 2012 assessment of La Viña as a bimonthly, perfect bound, black and white, 68-page magazine and concluded:
 - a. The committee recognized that funding La Viña as a service, through the General Fund, is an issue affecting the overall Fellowship.
 - b. The committee acknowledged the increase in circulation by 8.6% from January 2011 to December 2012 may be tied to the changes in format and additional content.
 - c. The committee acknowledged that the 2012 increase in La Viña deficit results in large part

- from allocation of pension funding expense.
- d. The committee expressed concern that funding La Viña through the General Fund of the General Service Board, while AA Grapevine Inc. has responsibility for the production of La Viña, may suggest an imbalance between responsibility and authority.
- 3. The committee considered discontinuing the requirement for the current format of the La Viña print magazine (i.e., 68 pages, perfect bound) and took no action. The committee needed more background regarding La Viña's financial history and information regarding what a new format would be.
- 4. The committee discussed a suggestion to add an index to *Alcoholics Anonymous* and took no action, noting that our Big Book is spiritual in nature rather than academic and that an index might discourage a full reading of the material.

The following Recommendations which did \underline{not} result in advisory actions were discussed:

- 1. The committee recommended that the second paragraph on the inside front flap of the dust jacket be changed by adding some of the wording that was previously in the third edition.
- 2. The committee recommended that "Non-alcoholics may attend open meetings as observers" be added to the open meeting side of the Primary Purpose (Blue) Card (F-17) in all three languages when the inventory of the English version is depleted.

The following Floor Actions were discussed:

- 1. The General Service Board's proposed plan of an interlocking directorate serving the A.A.W.S. and Grapevine, shall be continued in scope and procedure as proposed to the General Service Conference. (Conference voted not to consider)
- 2. The commemorative 75th Anniversary Edition of the First Edition, first printing of *Alcoholics Anonymous* is published in April 2014 in English, Spanish and French. (**Not approved**) The arguments against having the commemorative edition published in Spanish and French centered around the financial costs of printing translations which cost more than merely photocopying English. The argument also centered around the idea of where to stop on translations, for if we allow Spanish and French to be published then why not other languages. Lastly there was an argument based on historical accuracy due to the printing of *Alcoholics Anonymous* in Spanish and French happening less than seventy-five years ago.

Rich explained that the best decisions that could have been made this year were made and that he finds himself fortunate to have been involved as the Area 20 delegate for the past two years. He requests that no one shies away from being a delegate because if he feels if he can do it, anyone can.

The paradox is that two of the biggest steps in all of Alcoholics Anonymous is on two little paragraphs, (Steps) 6 & 7.

These are the tools of change.

These are the tools of acceptance.

A lot of people talk about just running around accepting things - I accept this, I accept that. Well I can't do that.

Acceptance comes after some actions of Steps 6 & 7

You know there's a story in that other book (Bible) about this guy named Judas.

Judas <u>could not accept</u> what he had done. (Betrayal) So what did he do? He killed himself. That's the importance of acceptance. You can't accept anything unless you take some action. He didn't do Steps 6 & 7 - didn't have them

And the other story is, there's a story in this other book about this guy, his name was Saul. Saul was riding his ass on the way to Damascus. A big bolt of lightening came down and knocked him off his ass, on his ass. That's the way I read it. He gets up and he dusted himself off and this big voice came out of the sky and said, "Saul, can we talk?"

"Yeah, we can talk, what you want to talk about?"

Had to get his attention didn't he. Maybe alcoholism has to get our attention.

"Saul you've been a very selfish individual and you've harmed a lot of people and you're very resentful and angry. And you've harmed a lot of people by those attitudes and I want you to quit doing that?"

And he said, "How do you quit doing that?" He said, "Do these things and if you'll do that then you'll make a change, and when you change then we'll call you Paul. Well he did those things and became Paul.

Now we know that Paul was one of the greatest writers the world's ever known.

And the Corinthians, the town of Corinthians, they asked Paul one day, "Paul, what is this secret to living?"

And he said, "The secret to living is daily dying." The old Saul had to die so the new Paul came alive.

(Steps) 6 & 7. By the time I got to 6 & 7 I could see what I had become as a result of the previous steps and I didn't like what I had become and a little doubt crept in my mind. Can God really change me from what I had become to what he intends for me be? And then I had to reaffirm and rethink about this idea on page 53. It said,

Big Book, pg. 53, par 3
God either is, or He isn't?

J & C He either can or he can't

Big Book, pg. 53, par 3.
What was our choice to be?

J & C And I chose to believe that he could. The tools of change.

To change from what I had become to what God had intended me to be. Steps 6 & 7 - Two of the biggest Steps in all of Alcoholics Anonymous.

Just before the break I want Joe to tell you one little story about buying some salad to show you practicing this thing. A few years ago I went into a grocery store to buy some salad and some stuff to fix for a salad - that night was having steak. I went in there and bought this stuff and came back up to the register and I was going to pay up and I gave this lady ten dollars and she took the ten dollars and stood right there and counted me out change for a twenty, and I watched her do it. And I picked up that money and I put it in my pocket and I got out to my car and I sat there and I said well you big dummy you sold out for ten bucks. I thought it was worth more than that, I'm glad it wasn't less than that.

So I took the money back in there and I told the lady I said you know I'm a member of a fellowship that **requires me to be honest** and you gave me too much money and I want to give you this ten dollars back. And she said, you know I never heard of a fellowship like that and I said, "well I hadn't either till a few years ago, so here's your ten bucks back." The whole point of this story, when I walked out with that ten dollars, and believe I don't need ten dollars; I mean I do not need ten dollars. And I'm walking out I felt about that big, sneaking out the door. You see then I went back in there and gave her that ten bucks back and I walked out and I feel good again. I did the right thing. If you practice that enough times the next time she gives change for a twenty you do it right there you don't even go out the door with it.

That's what we're talking about when we change and only we can do it.

Only we can slay ourselves with God's help and become different human beings

So if you stay dishonest, self-seeking, frightened and inconsiderate it must be because you want to

J & C We've completed our first seven steps knowing full well we're going to be working on (Steps) 6 & 7 for the rest of our lives really, trying

to change as the opportunity comes up.
